WARNING, ASSUMPTION OF RISK, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT AND PHOTO RELEASE.

2010 FANS ON THE FIELD RUN/WALK EVENT

The event participant identified below is at least 18 years old, or if the event participant is younger than 18 (the "Minor"), the Minor's parent or legal guardian has read this agreement and has signed it on behalf of him/herself and the Adult signing on behalf of the minor child or protected person named below ("Protected Person") if applicable. The adult competitor or the Minor's parent or legal guardian, will be referred to herein as "Adult", and Adult and Protected Person are collectively referred to as the "Undersigned." "Participant" refers to the person actually taking part in the Fans on the Field Run/Walk event (the "Event") which includes but is not limited to races, competitions, demonstrations, training and other such events and activities associated with the Event. **The Undersigned understand that Participant will not be permitted to take part in the Event unless this Warning, Assumption of Risk, Release of Liability and Indemnification Agreement and Photo Release ("Agreement") is fully executed.**

The Undersigned acknowledge that the risks and hazards of running and/or walking increase during a race, competition, and contest due to the competitive nature of the activity and due to other participants on the Event course. **Undersigned understand that the Event involves risks of injury and death.** There are risks inherent in the Event including, but not limited to walking or running on uneven surfaces, streets, roads, and sidewalks, walking or running in or around Event venues, barriers, other competitors, spectators, officials, and motorized vehicles. Course conditions may change quickly due to weather, use and other factors and may not be the same during a race as during practice or inspections by Participant. Falls and collisions with objects on or about the Event course, pedestrians, other competitors and vehicles do occur, and injuries are a common and ordinary occurrence for Participants. Undersigned also understand that outdoor activities and especially those conducted at high altitudes involve certain dangers and risks that can lead to serious injury and death. Such dangers and risks include, without limitation, rapidly changing weather conditions, dehydration, overexertion, exposure to the sun, hail, rain, lightning, and reduced oxygen in the air at high altitude. Undersigned understand that trucks, bicycles, vehicles and other equipment may be encountered at any time and Participant must be alert for and avoid them. **RECOGNIZING THE RISKS, ADULT VOLUNTARILY CHOOSES TO TAKE PART IN THE EVENT AND, IF APPLICABLE VOLUNTARILY CHOOSES TO ALLOW PROTECTED PERSON TO TAKE PART IN THE EVENT AND REPRESENTS THAT PARTICIPANT HAS THE SKILLS AND DEXTERITY TO PARTICIPATE IN THE EVENT AND WILL AT ALL TIMES COMPETE WITHIN HIS/HER ABILITIES.**

By signing this Agreement Adult on his/her own behalf and, if applicable, on behalf of Protected Person acknowledges the risks and dangers associated with the Event generally and, as a condition to Participant engaging in the Event, agrees to (1) ASSUME ANY AND ALL RISKS OF INJURY OR DEATH to Participant while or as a result of participating in the Event; (2) WAIVE, RELEASE, and NOT SUE, MAKE ANY CLAIMS OR FILE ANY ACTIONS against the National Sports Center for the Disabled (NSCD), operators of venues for the Event and each of their insurance carriers, subsidiaries, affiliates, officers, directors, shareholders, members, representatives, assignees, employees, volunteers and agents, as well as any Event sponsors and Equipment manufacturers and distributors (hereinafter the "Indemnified Parties") that are based on, arise or result from, in whole or in part, participation in the Event; (3) INDEMNIFY, DEFEND AND HOLD THE INDEMNIFIED PARTIES HARMLESS, from any and all claims, demands, actions, causes of action, losses or liabilities whatsoever arising from or related to participation in the Event and any loss, damage or injury, including death, that may be sustained by Participant or caused to others or their property by Participant. Undersigned agree to pay all costs, including reasonable attorneys' fees and disbursements, incurred by any Indemnified Party in defending an investigation, claim or suit brought by or on behalf of Undersigned.

The Undersigned warrant and represent that Participant is in good health and has the physical stamina and dexterity to safely participate in the Event. Participant is encouraged to have his/her own health insurance.

Undersigned give the NSCD permission to take and use photographs, video recordings, or movies of Participant taken during the Event and use and sublicense such material for any purpose for any purpose in promoting the NSCD, or related activities of the NSCD in print, brochures, advertisements, films or videos and on broadcast presentations of any sort.

In consideration for participating in the Event, Adult agrees for him/herself and Protected Person that **ALL** claims arising from or related to any Event, including for injury to person or property and/or death shall be **GOVERNED BY COLORADO LAW, without regard to conflicts of law principles**, and that **EXCLUSIVE JURISDICTION** shall be in the **District Court in Denver County, Colorado or in Federal Court for the District of Colorado. UNDERSIGNED VOLUNTARILY AND IRREVOCABLY WAIVE ANY OBJECTION TO SUCH LAW AND JURISDICTION.**

This Agreement shall be binding to the fullest extent permitted by law. If any provision of this Agreement is found to be unenforceable, the remaining terms shall be enforceable. **THE UNDERSIGNED PARENT OR LEGAL GUARDIAN REPRESENTS AND ACKNOWLEDGES THAT HE/SHE IS ENTITLED TO AND IS SIGNING THIS AGREEMENT ON BEHALF OF PROTECTED PERSON AND THAT PROTECTED PERSON WILL BE BOUND BY ALL THE TERMS OF THIS AGREEMENT. UNDERSIGNED UNDERSTAND AND AGREE THAT IF THIS AGREEMENT IS NOT SIGNED ON BEHALF OF PROTECTED PERSON, PROTECTED PERSON WILL NOT BE PERMITTED TO PARTICIPATE IN ANY EVENT.** This Agreement shall be binding upon Undersigned's assignees, subrogors, distributors, heirs, next of kin, executors and personal representatives.

UNDERSIGNED HAVE CAREFULLY READ THIS AGREEMENT, UNDERSTANDS ITS CONTENTS AND SIGN IT WITH FULL KNOWLEDGE OF ITS SIGNIFICANCE.
